The next London Brokerage Network training course is starting 19th April 2017.

I am now offering low cost accredited training around Self Directed Support, Personalisation, Personal Budgets, Direct Payments, Support Planning & Brokerage training. It is accessible for professionals, disabled people and carers alike and spread over 5 one day sessions.

In 2016, I was appointed the Public Champion for Mobilising Community Assets by NHS England (Healthy London Partnership) and now sit on their Personalisation and Self-Care Delivery Board as well as a steering committee to design an online support planning programme. Due to my models of Brokerage, as outlined in the training, this role was created for me and I am contributing to guidance for commissioners on community brokerage and social prescribing amongst other things. I believe this gives further validation to the quality of the training and why it remains important. I have spoken on this at two conferences for the Social Prescribing Network.

This course can be undertaken with or without formal accreditation (by OCN Credit 4 Learning).

The training is also the gateway to membership of the London Brokerage Network, the first voluntary professional association for Brokers in the UK. I hope you will take the time to look at the new website and consider the benefits of membership.

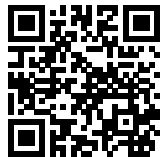

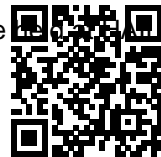
